(b) It is expressly understood and agreed that this ld shall never be occupied by any person of African descent, commonly known as negro, except that the same may be occupied by such negroes only and whole employed as a domestic or domestics by any person residing on said premises.

Said Trustee, on behalf of those owning the beneficial interest in said real estate at the time of the execution of this deed, as is shown in a certain Trust agreement now of record in the office of the County Clerk, Ex-Officio Register of Deeds of said County and State, dated the 15th day of November, 1919, but not on behalf of itself, covenants and agrees with the party of the second part that the party of the first part at the time of delivery of these presents is seized of a good and indefeasible title and estate of inheritance in fee simple in and to said real estate and covenants that it is in peaceful, and undisputed possession of said premises, with full right and power to convey the same by this instrument to said party of the second part, and that the same is clear, free, and discharged of and from all former and other grants, charges, taxes, judgements and other liens or encumbrances of whatsoever kind or nature, and hereby binds those having the beneficial interest in said premises, their heirs and assigns, forever, to observe the covenant and agreements herein contained and to warrant and defend the title to said land, against all claims of every nature.
