If the parties of the second part, their heirs, executors, administrators or assigns shall violate any of the restrictions in this deed in any way, either the grantors herein or any owners of any real estate in East Highland, an addition to the City of Tulsa, Tulsa County, Oklahoma, may enforce said restrictions in any court of competent jurisdiction either by suit for injunction or to recover damages.
