RIGHT OF WAY AGREEMENT.

And also there is hereby granted a right to erect and maintain a telephone and telegraph line. The rights herein granted shall permit the use of such land as may be necessary for said pipe line and for said telegraph and telephone line, and shall also permit the grantee herein, its successors and assigns, to do whatever may be necessary to thear construction, or for the enjoyment of the rights herein granted, including the right of ingress and egress to and from said tract of land for the purpose of laying, maintaining, repairing and restoring of said pipe line: and said telegraph and telephone line, and for removing of same when desired by the grantee, its successors end assigns.
