RIGHT OF WAY AGREEMENT.

The rights herein granted shall permit the use of such land as may be necessary for 4sid pipe line and for said telegraph and telephone line, and shall also permit the grantee herein, its successors and assigns, to downatever may be necessary to their construction, or for the enjoyment of the rights herein granted, including the right of ingress and egress to and from said tract/of land for the purpose of laying, maintaining, repairing and restring of said pipe line and said telegraph and telephone line, and for removing of same whendesired by the granteee, its successors and assigns.
