The damage for and because of the laying of the first line of pipe are included in the above payment. All damages thereafter to fences, crops and premises which may be suffered by reason of meintenance, operation of altertion of said lines of pipe, said damages, if not mutually agrees upon to be ascertained and determined by three disinterested persons, one thereof to be appointed by the owner of the premises, one by Cosden Pipe Line Company, its successors or assigns, and the third by the two so appointed as aforesaid, and the award of two of such three persons shall be final and conclusive.

To have and to hold the said essement unto the said CosdenPfpe Line Company, its successors and assigns, so long as the same shall be useful for the purpose desired of by said grantee, which by the acceptance hereof covenants and agrees with the granter that the pipe line shall be buried so as not to interfere with the cultivation of the same.

It is understood that the person securing this right of way for said company is without authority to make any agreement, covenant, of promise in its behalf not herein specifically shown, and this instrument is delivered and accepted upon the distinct understanding that the consideration herein above stated is the sole consideration and inducement therefor.
