them in undivided equal shares, subject to the right of each and all of said named persons to have the name maintained as a homestead so long as they may not have acquired another and different homestead.

The Court, being fully advised in the premises, doth order, adjuge and decree that the north 35 flet of the lot 9 and the south 25 feet of the lot 10 of Block 2, in Stone braker Heights ad dition to the City of Tulsa, Tulsa County, Oklahoma, be and the same is hereby set aside to Florence L. Kistler, widow, and William Lenix Kistler and Florence Louise Kistler, minor children of the decressed, to be used, possessed and occupied as their home, pursuant to the laws of this state, so long as another homestead may not have been acquired, and that title to the said property be vested absolutely in the said Florence L. Kistler, William Lenix Kistler and Florence Louise Kistler, to be owned by them in equal shares in fee Simple forever.

It is further ordered by the Court that the acts and conduct of the administrators herein in not taking possession of the said real estate of which the deceased was seized at the time of his death, and in permitting the said widow and children constituting the family of the deceased to possess and occupy the same from and after the death of the deceased, be in all things approved and forfirmed, and the said described real estate, together with all improvements therein is further adjudged by the Court to be not a part of the assets of the estate of the deceased, and the said administrators are authorized to wholly exclude the said described real estate from administration, and to take no account of the same in the further adminustration of the estate of the said deceased.
