 - 5.- Residences on corner lots shall have a presentable frontage on both streets.

- 8. No bill-boards or advertising sign shall be erected or maintained on this lot, nor shall any building or structures be erected thereon for advertising purposes.
- 9.- No garage or other authuilding shall be erected upon this ld for use for temporary residence purposes.

It is further agreed that the present rasidence shall be used as such until December, 1924 only at which time it must be vacated, a residence as above described erected, or lot vacated, or same reverts back to grantor, as penalty in lieu of lack of fulfillment of this contract.
