All certificates, contracts, stationery and business documents or instruments used by the Trustees in the execution of their trust, shall bear certain designated printing or engraving (the style of which shall be within the discretion of the Trustees) to be per se that the Aladdin Oil & Drilling Co., is a trust organization.

Nineteenth. (a) This trust shall continue for the term of twenty one years (21) at which time the then board of Trustees shall wind up its affairs, liquidate its assets and distribute the same among the holders of the units held under and by virtue of this Trust; Provided, however, that if prior to expiration of said period the Trustees at a meeting called for that purpose by a majority vote, determine ^{to terminate} or continue for such further period as may be determined. (b) for the purpose of winding up the affairs and liquidating the assets of the trust, the then board of Trustees shall continue in office until such duties shall have been duly performed. (c) This agreement and declaration of Trust may be amended or altered in the event such amendment or alteration becomes necessary and imperative to the expedient execution of this trust except in regard to the liability of the Trustees or Unit holders at an annual meeting of the Trustees by unanimous vote of the Board of Trustees and such amendment or alteration shall be annexed to, and made a part of this agreement, and a copy thereof shall be filed with the register of deeds of Tulsa County, Oklahoma.
