KNOW ALL MEN BY THESE FRESENTS: That Ellen Atwood, nee Graham, and Lee Atwood, her husb band of the Postoffice of Collinsville, State of Okla, hereinafter called lessor (whether one or more), for and inconsideration of one dollar and other considerations, cash in hand paid, receipt of which is hereby acknowledged, does hereby leases unto A. H. Huling hereinafter called lessee, the following described land, situated in the County of Tulsa, and State of Oklahoma;

The East Half of the South west quarter, and the South west quarter

of the Southwest quarter, all in Section 21, Township 22 North, Range

14 East, containing 120 acres more or less,

The purpose of this lease is such that so long as it remains in force the lessee shall have the exclusive right to prospect and drill on said land for oil and gas and remove the same thereform; to erect and maintain thereon and remove therefrom all necessary or proper/ structures and equipment, including the right to pull the casing from wells; and to install and maintain thereon and remove therefrom all tanks and other means of storage and all pipes and other means of transportation; also the right of ingress and egrees at all times for any of said purposes.
