option of the legal holder thereof, and if collected by suit, ten per cent additional shall be allowed, as attoney's fee, the said fee in any case to be at least Twenty-five Dollars; provided, that the maker of this note may have the privilege of paying Fifty Dollars, or n any multiple thereof, or all, on the principal sum, by paying one month's interest in advance, on the amount so paid, as prescribed by the By-Laws, and have the interest payments reduced accordingly.
