DA ARED

such holder; and said second party, its successors or assigns, or any legal holder hereof shall at once, upon the filing of a bill for the foreclosure of this mortgage, be forthwith entitled to the immediate possession of the above described premises, and may at once take possession, and receive and collect the rents, issues and profits thereof; and it is further agreed that the contract embodied in this mortgage and note secured hereby hhall, in all respects be governed, construed and adjudged according to the laws of the State of Oklahoma, at the date of their execution. PROVIDED, That no stipulation contained in this mortgage shall in anywise be deemed to impair the negotiability of such note.

Tenth. That in case of a foreclosure of this mortgage, and as often as any proceedings shall be taken to foreclose same, the first party shall pay to the plaintiff therein a reasonable attorney's fee of \$150.00, together with abstracter's fee for supplemental mabstract, of title for use in said foreclosure proceedings, such fee to be due and payable upon the filing of petition for foreclosure, and the same shall be a further charge and lien upon the said premises; that upon the institution of proceedings to foreclose this mortgage, the plaintiff therein shall be entitled to have a receiver appointed by the court to take posession and control of the premises described herein, and to collect the rents and profits thereof, under the direction of the court, without the proff required by statute; the amount so collected by such receiver to be applied, under the direction of the court, to the payment of any judgement rendered or amount found due upon the foreclosure of this mortgage; the first party hereby waives all benefits of the stay, appraisement, and exemption laws of the State of Oklahoma, this waiver to be effective or not at the option of the second party.

Eleventh. In construing this mortgage the words, "first party" shall be held to mean the person or person named in the preamble as parties of the first part jointly and severally; and the words "second party" shall include this mortgages herein, and its successors or assigns.
