Cathers the following described real property and premises situate in Tulsa County, State of Oklahoma, to-wit:

The North Half of the Northeast Quarter of Section 15, Township 18 North, Range 12 East,

together with all the improvements thereon and the appurtenances thereunto belonging.

TO HAVE AND TO HOLD said described premises unto the said Preston B. Cathers, his heirs and assigns, forever, free, clear, and discharged of and from all former grants, taxes, judgements, mortgages, and other liens and encumbrances of whatsoever nature.
