WITNESSETH, That said parties of the first part, in consideration of the sum of One (\$1.00) DOLLARS to them duly paid, the receipt of which is hereby acknowledged has quit claimed, granted, bargained, sold and conveyed, and by these present do for themselves heirs executors and administrators, quit claim, grant, bargain, sell and convey unto the said parties of the second part and to their heirs and assigns, forever, all their right, title interest, estate claim and demand both at law and equity in and to all the following described property, to-wit:

Lot Ten (10) in Block Two (2) in Stansberry Addition to the City of

Tulsa, Tulsa County, Oklahoma, according to the recorded plat thereof.

(This deed is made to correct an error in a former deed executed by the Grantors herein to Lon R. Stansberry dated June 30th 1905, and recorded June 30, 1905 in Book "Y" at Page 232 of the records in the office of the County Clerk, Tulsa County, Oklahoma, which deed was acknowledged before Robert E. Lynch who failed to sign the acknowledgment as a Notary Public.)
