COMPARED

THIS AGREEMENT, Made this 6 day of June 1923, by and between Joe H. Tiger party of the first part, and Neff & Neff, being William Neff and L. E. Neff, parties of the second part;

WITNESSETH: That the party of the first part hereby employ the parties of the second part to bring suit and to recover for the party of the first part whatever interest he may have in the following described land, to-wit:

Lot One (1), Lot Four (4), Northwest Quarter of Northeast Quarter,
North half of southeast quarter of northeast quarter of Section
Twenty Four (24) and South Half of Northwest Quarter of Southwest
quarter of Section Eleven (11) Township Nineteen (19) North, Range
Twelve (12) East,

and the rents and profits thereof and for all oil and gas taken therefrom, and the party of the first part agree to give to Parties of the Second Part, one-half of whatever may be recovered from the Party of the First Part, whether in land or in money and whether by judgement or by settlement; and the Party of the First Part give the Parties of the Second Part, a lien upon the above described land and upon the subject matter of the action to secure the payment of the attorney's fees herein contracted to be paid; and the Party of the First Part agree to execute any further instrument which may be necessary so that the Parties of the Second Part may receive one-half of whatever interest in said land and in the rents and profits and in the oil and gas taken therefrom the Party of the First Part, may now have the right to recover.
