To operate and develop oil lands, gas lands, coal lands or other mineral lands; to or purchase, lease, rent, take/otherwise acquire. vand to lease, sell, assign, sub-lease and otherwise dispose of, whether by purchase, sale, exchange, or in any manner whatsoever, proven, prospective or potential oil lands, gas lands, coal lands, and other mineral lands and leased thereon, and leasehold estates and other estates therein;

To transport for hire, or otherwise, oil, gas and water; to procure, store, transport, sell and furnish by means of pipe lines, or otherwise, oil gas or water for the purpose of carrying on the work, business and operations of this Trust, and for the purpose of supplying other Trusts, corporations, public or private, firms or individuals with oil, gas or water to anable them to carry on operations in which they are or may be engaged; to buy, lease, build or otherwise acquire, and to own and operate, and to sell, lease or otherwise dispose of telegraph and telephone lines, railways, conduit, lines, pipe lines, lines for conducting electricity, or other lines or systems, including rights-of-ways, terminals, docks, piers, tanks, cars, vessels, ships, and barges for the transportation of oil, gas, coal or other minerals or mineral substances, and of the products and by-products thereof, and the materials for supplies used in connection with the production, refining and marketing of the same, or in connection with any of the other purposes of this Trust; and also, to acquire, own or dispose of such easements, rights-of-way, franchises and privileges as may be necessary or convenient in connection with said transmission and transportation lines; and generall to do all and everything necessary, suitable or convenient for the accomplishment of any one or more of the purposes, or for the attainment of any one or more of the objects enumerated herein.

To do all kinds of mining, manufacturing, transporting of oil, gas, coal, or other minerals and their products or by-products, and goods and merchandise, by land or water, in any manner;

To acquire by purchase or otherwise, own, sell, assign and transfer, contracts, fnanchises and rights; to furnish natural gas, and/gas manufactured from oil or other substances, or the products or by-products thereof, to cities, towns, villages, persons, firms and corporations, public and private, for lightning, heating, power and all other domestic and industrial purposes; to manufacture, buy, sell and deal in machinery, apparatus, and supplies, appropriate and convenient to the manufacture, utilization and distribution of matural gas or manufactured gas for lighting, heating, power, and other purposes; and generally to do all things necessary or incident to said business.

To acquire and pay for in cash, stocks or bonds of this Trust, or otherwise, the good will, rights, assets and property, and to undertake or assume the whole or any part of the obligations or liabilities of any person, firm, association or corporation, public or private.

To acquire, hold, use, sell, assigns, lease, grant licenses in respect of, mortgage, or otherwise dispose of letters patent of the United States or any foreign country, patent rights licenses and privileges, inventions, improvements and processes, copyrights, trade-marks and trade names, resating to or useful in connection with any business of this Trust.

To subscribe for, guarantee, purchase, hold, sell, assign, transfer, mortgage, pledge or otherwise dispose of shares of the capital stock of, or any bonds, securities or evidence of indebtedness created by, any other Trust or Trusts or corporations organized under the laws of this State, or any other State, County, Nation or Government, and while the owner thereof to exercise all the rights, prowers, and privileges of ownership, including the right to vote same.

To issue bonds, debendures or obligations of this Trust from time to time, for any of
