The North half of Lot 8 and a strip of land 33 feet wide running north and south across the east end of the South half of said lot, and the South half of Lot 5, except the north sixteen and one-half feet ($16\frac{1}{2}$) thereof, all in section 24, township 19 North, Range 12 East, containing 27 acres, more or less.

That in said deed title to said property was warranted subject to a mortgage securing a note in the sum of Ten Thousand Dollars (\$10,000) to W. B. Price as payee; that through inadvertence the name of the payee of the note and the mortgagee in the mortgage securing the same was written as W. B. Price instead of R. B. Price; that the only mortgage outstanding was the one to R. B. Price and that the W. B. Price mentioned in said deed should have been referred to as R. B. Price the mortgagee then of record.
