## ASSIGNMENT OF MORTGAGE

COMPARED

FOR AND IN CONSIDERATION of One Dollar and other good and valid considerations in hand paid to me by John W. Drake, hereinafter called assignee, of Rio Grande County, Colorado, whose address is Monte Vista, Colorado, and as security for the payment to assignee of my two certain promissory notes, and interest, one of which said notes is in the principal sum of One thousand (\$1,000.00) Dollars, bearing date April 25th 1921, due and payable September 1st, 1921, with interest at the rate of ten per cent per annum from the date thereof until paid, and one of which said notes is in the principal sum of One Thousand eighty-three (\$1083.00) Dollars bearing date March 1st, 1921 and is due and payable on the 1st day of March, 1922, together with interest thereon at the rate of eight per cent per annum from the date thereof until paid.

I, ALBERT SIDNEY HARBOUR of Rio Grande County, Colorado, do hereby assign, convey, transfer and mortgage unto assignee all my right, title and interest in and to the estate of my father, John J. Harbour, who departed this life on or about the 17th day of July 1919, and whose estate is now in process of administration in the County of Tulsa, State of Oklahoma, hereby giving assignee full power and authority to demand, sue for, receive and remove my distributive share of said estate as heir at law of the said John J. Harbour, deceased, and to give effectual discharges, receipts and releases therefor the same as I could have done had this assignment not been made.

To hold my said distributive share in said estate unto assignee, his executors, administrators and assigns upon trust to receive the same, and there out of in the first place to pay all costs and expenses of and incidental to obtaining payment thereof, and in the next place to apply the proceeds of my said distributive share toward payment of the principal and interest of the promissory notes above described, and to pay the surplus if any unto the undersigned.
