WITNESSETH, That said part Eliza Harris of the first part, in consideration of the sum of One Dollar and other  
valuable consideration, to me duly paid, the receipt whereof is hereby acknowledged, do GS hereby quit-claim, grant, bargain, sell and convey unto the said part Y  
of the second part, and to his heirs and assigns forever, all my right, title,  
interest and estate, both at law and in equity, of, in and to the following described real estate in the County of Tulsa,  
and State of Oklahoma, to-wit:

Parts of lots Eleven (11) and Twelve (12) in Block Sixteen  
(16) in Greenwood Addition to City of Tulsa, Oklahoma, and  
more particularly described as follows; Beginning at a  
point Sixty-nine (69) feet South of NW corner of Lot Twelve  
(12) on West line, thence one hundred (100) feet across lots;  
Twelve (12) and Eleven (11) and parallel to the North line of  
said lot to the East line of lot Eleven (11) thence Fourteen  
(14) feet North on East line of Lot Eleven (11), thence One  
Hundred (100) feet West across lots Eleven (11) and Twelve (12)  
and parallel to the North line of said Lots to the West line of  
Lot Twelve (12) thence South on west line of lot Twelve (12)  
Fourteen (14) feet to the point of beginning.
