Y of the second part, and to his heirs and assigns forever, all right, title, interest and estate, both at law and in equity, of, in and to the following described real estate in the County of Tulsa, and State of Oklahoma, to-wit:

The Jennie Brunner homestead, so called, being forty acres, more or less, comprised by the Southeast Quarter of the Southeast Quarter of Section Six, Township Nineteen North, Range Twelve East (SE 1/4 SE 1/4 Sec. 6-T 19 N.- R. 12 E.);

And as further consideration for the sum of money hereinbefore set forth said Dan Pilcher & Mollie E. Pilcher his wife, do hereby sell, assign, convey and set over unto the said Edwin L. Gluck, his heirs and assigns, all of said assignors right, title and interest in and to the oil and gas heretofore or hereafter produced from the above described land, together with the said assignors right to the proceeds of any oil or gas heretofore marketed from said land;
