WITNESSETH, The said parties of the first part, in consideration of the sum of Two Hundred and no DOLLARS,
 the receipt whereof is hereby acknowledged, do hereby these presents grant, bargain, sell and convey unto the said
 parties of the second part, Their heirs and assigns, all of the following described real estate, situated in the
 County of Osage and State of Oklahoma, to-wit:

Lots One (1), Two (2), Three (3) and Four (4) in block
no Ten (10) in The Townsite of Glenpool, Osage Co. Okla.

TO HAVE AND TO HOLD THE SAME, together with all and singular the tenements, hereditaments and
 appurtenances thereunto belonging or in any wise appertaining forever.

And said O. Marckle and N. J. Marckle M. O. Self and Ediga Self for Their
 heirs, executors or administrators, do hereby covenant, promise and agree to and with said parties of the
 second part, that at the delivery of these presents They are lawfully seized in their own
 right of an absolute and indefeasible estate of inheritance, in fee simple, of, in and to all and singular the above
 granted and described premises, with the appurtenances; that the same are free, clear, discharged and unincum-
 bered of and from all former grants, titles, charges, judgments, taxes, assessments and incumbrances, of what
 nature and kind soever; except an Oil Gas and mining lease now existing on said land
 and that They will warrant, and forever defend the title to the same unto said parties of the second part Their
 heirs and assigns, against said parties of the first part their heirs and all and every person whomso-
 ever, lawfully claiming or to claim the same.
