 the receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell and convey unto the said
 part 2d of the second part, her heirs and assigns, all of the following described real estate, situated in the
 County of Tulsa and State of Oklahoma, to-wit:

to the town of Tulsa Oklahoma according to the official and
recorded plat thereof

TO HAVE AND TO HOLD THE SAME, together with all and singular the tenements, hereditaments and

And said Ross Sigler and Jessa Sigler for their
 heirs, executors or administrators, do hereby covenant, promise and agree to and with said part 2d of the
 second part, that at the delivery of these presents they are lawfully seized in their own
 right of an absolute and indefeasible estate of inheritance, in fee simple, of, in and to all and singular the above
 granted and described premises, with the appurtenances; that the same are free, clear, discharged and unincum-
 bered of and from all former grants, titles, charges, judgments, taxes, assessments and incumbrances, of what
 nature and kind soever; except a mortgage of \$2200 to L. H. Moore due Dec. 17th 1925
 and that they will warrant, and forever defend the title to the same unto said part 2d of the second part her
 heirs and assigns, against said part 1st of the first part their heirs and all and every person whomso-
 ever, lawfully claiming or to claim the same.
