Tulsa County, in the State of Oklahoma, of the first part, and R.E. Perry

of the second part,

WITNESSETH, The said parties of the first part, in consideration of the sum of _____
 and _____ DOLLARS,

the receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell and convey unto the said
 party of the second part, his heirs and assigns, all of the following described real estate, situated in the
 County of Tulsa and State of Oklahoma, to-wit:

a Portion of lot nine (9) in Block one hundred and thirteen (113) in City of Tulsa
 Oklahoma, beginning at the southeast corner of said lot 9, running thence
 north to a stake set in the ground on the street line; thence in a direction
 touching two pear trees to a stake set in the ground on the east line between
 lots eight (8) & nine (9); thence on said lot line between lots (8) & (9) to the southeast
 corner of said lot; thence on south line to place of beginning.

(Grantor reserves to his own use the two pear trees now standing in
 north line of property above conveyed)

TO HAVE AND TO HOLD THE SAME, together with all and singular the tenements, hereditaments and
 appurtenances thereunto belonging or in any wise appertaining forever.

And said Thora Stahl & W.B. Stahl for their
 heirs, executors or administrators, do hereby covenant, promise and agree to and with said party of the
 second part, that at the delivery of these presents they are lawfully seized in own
 right of an absolute and indefeasible estate of inheritance, in fee simple, of, in and to all and singular the above
 granted and described premises, with the appurtenances; that the same are free, clear, discharged and unincum-
 bered of and from all former grants, titles, charges, judgments, taxes, assessments and incumbrances, of what
 nature and kind soever;
 and that they will warrant, and forever defend the title to the same unto said party of the second part his
 heirs and assigns, against said party of the first part their heirs and all and every person whomso-
 ever, lawfully claiming or to claim the same.
