50.00 cash herewith paid and the balance in two notes for \$175.00 each due in 1 and 2 years
 the same is hereby acknowledged, do by these presents grant, bargain, sell and convey unto the said
 part 2nd of the second part, his heirs and assigns, all of the following described real estate, situated in the
 County of Tulsa and State of Oklahoma, to-wit:

The South twenty five (25) feet of Lot Eleven (11) in Block
Three (3) in the Durley Addition to the City of Tulsa
According to the Original plat thereof; in said County
and State.

The said land now being the homestead of Grantor.

TO HAVE AND TO HOLD THE SAME, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining forever.

And said Wm Collins for his
 heirs, executors or administrators, do by hereby covenant, promise and agree to and with said part 1st of the
 second part, that at the delivery of these presents he lawfully seized in his own
 right of an absolute and indefeasible estate of inheritance, in fee simple, of, in and to all and singular the above
 granted and described premises, with the appurtenances; that the same are free, clear, discharged and unincum-
 bered of and from all former grants, titles, charges, judgments, taxes, assessments and incumbrances, of what
 nature and kind soever; except the taxes for the year 1908 which Grantor assumes
and that he will warrant, and forever defend the title to the same unto said part 2nd of the second part his
 heirs and assigns, against said part 1st of the first part his their heirs and all and every person whomso-
 ever, lawfully claiming or to claim the same.
