the receipt whereof is hereby acknowledged, do hereby present, grant, bargain, sell and convey unto the said
parties of the second part, and to his heirs and assigns, all of the following described real estate, situated in the
County of Tulsa and State of Oklahoma, to-wit:

The North half of the north east quarter of the north west
Quarter (N 1/2 of NE 1/4 of NW 1/4) of Section Thirtieth (33) in
Township number twenty One (21) north of Range Thirteenth (13)
East - together with all and singular the hereditaments and appurtenances
thereunto belonging. Do here also to have the above granted
Premises unto the said party of the second part his heirs and
assigns forever.

TO HAVE AND TO HOLD THE SAME, together with all and singular the tenements, hereditaments and
appurtenances thereunto belonging or in any wise appertaining forever.

And said heirs, executors or administrators, do hereby covenant, promise and agree to and with said party of the
second part, that at the delivery of these presents lawfully seized in own
right of an absolute and indefeasible estate of inheritance, in fee simple, of, in and to all and singular the above
granted and described premises, with the appurtenances; that the same are free, clear, discharged and unincum-
bered of and from all former grants, titles, charges, judgments, taxes, assessments and incumbrances, of what
nature and kind soever;
and that will warrant, and forever defend the title to the same unto said party of the second part
heirs and assigns, against said party of the first part their heirs and all and every person whomso-
ever, lawfully claiming or to claim the same.
