Albert W. Reeves party of the second part.

Witnesseth: That in consideration of the sum of Fifty Two Hundred Fifty (\$5250.00) DOLLARS,  
the receipt whereof is hereby acknowledged, said parties of the first part do by these presents grant, bargain, sell and convey unto said  
part V of the second part his heirs and assigns, all of the following-described real estate, situated in the County of Tulsa, State of  
Oklahoma, to wit:

Lot Seven (7) in Block One (1) Ridgedale Terrace  
Second Addition to the City of Tulsa, Oklahoma,  
according to the recorded plat thereof,

Cancelled

To Have and To Hold the Same, Together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in anywise  
appertaining, forever.

And said Horace Anderson and Cecile Anderson (husband and wife) their  
heirs, executors or administrators, do hereby covenant, promise and agree to and with said part V of the second part that at the delivery of  
these presents that they are lawfully seized in their  
own right of an absolute and indefeasible estate of inheritance in fee simple, of and in all and singular the above granted and described premises,  
with the appurtenances; that the same are free, clear and discharged and unincumbered of and from all former and other grants, titles, charges,  
estates, judgments, taxes and assessments and incumbrances of whatsoever nature and kind, EXCEPT:

one certain mortgage dated dated July 24th, 1923, in favor of The Local  
Building and Loan Association of Oklahoma City, Okla., Adkinson & Henry Local  
Agents, being in the sum of \$3000.00 payable \$41.70 per month; also subject  
to a second mortgage dated July 27th, 1923, in favor of Title Guarantee &  
Trust Co. being in the sum of \$905.00, payable \$20.00 per month, beginning  
August 1st, 1923, all of which the party of the second part herein assumes  
and agrees to pay, and which is a part of the purchase price named herein.

and that they will warrant and forever defend the same unto the said part V of the second part his heirs and assigns  
against said part V of the first part, their heirs and assigns, and all and every person or persons whomsoever, lawfully claiming  
or to claim the same.
