To pay lessor One-eighth of the proceeds when sold for the gas from each well where gas only is found, while the same is being used on or off the premises and if used in the manufacture of gasoline or any other product, a royalty of one-eighth (1/8) payable monthly at the prevailing market rate; and lessor to have gas free of cost from any such well for all stoves and all inside lights in the principal dwelling house on said land during the same time by making his own connections with the well at his own risk and expense.

To pay lessor for gas produced from any oil well and used on or off the premises or in the manufacture of gasoline or any other product at the rate of One-eighth of the proceeds when sold for the time during which such gas shall be used, payable monthly or a royalty of one-eighth (1/8) payable monthly at the prevailing market rate.
