And it is agreed that upon the resumption of the payment of rentals, as above provided, that the last preceding paragraph hereof, governing the payment of rentals and the effect thereof, shall continue in force just as though there had been no interruption in the rontal payments. If said lessor owns a less interest in the above described land than the entire and undivided fee simple estate therein, then the royalties and rentals herein provided for shall be paid the lessor only in the proportion which <u>Filts</u> where you and undivided fee. Lessee shall have the right to use free of cost, gas, oil and water produced on said land from <u>files</u> operations thereon, except water from well of lessor.
