To deliver to the credit of lessor, free of cost, in the pipe line to which <u>he</u> may connect. <u>his</u> wells, the equal one-eighth part of all oil produced and saved from the leased premises.

2nd. To pay lessor for gas from each well where gas only is found, the equal one-eighth (1/8) of the gross proceeds at the provalling market rate, for all gas used off the premises, said payments to be made monthly and lessor to have gas free of cost from any such well for all stoves and all inside lights in the principal dwelling house on said land during the same time by making his own connections with the well at his own risk and expense.

3rd. To pay lessor for gas produced from any oil well and used off the premises or for the manufacture of casing-head gas, one-eighth (1/8) of the gross proceeds at the prevailing market rate for the gas so used, for the time during which such gas shall be used, said payments to be made monthly.

If no well be commenced on said land on or before the <u>5th</u> day of <u>February</u> <u>19</u>25, the lease shall terminate as to both parties, unless the lease on or before that date shall pay or tender to the lessor, or the lessor's credit in the <u>Planters</u> and <u>Liechancis</u>
