James S. Terry. Tulsa. Oklahoma WITNESSETH, That the said lessor, for and in consideration of One Dollar (\$1.00 and other good andBellars). Ocash in hand paid, receipt of which is hereby acknowledged and of the covenants and agreements hereinafter contained on the part of lessee to be paid, kept and performed, has granted, demised, leased and let and by these presents do. 98 grant, demise, lease and let unto the said lessee, for the sole and only purpose of mining and operating for oil and gas, and of laying of pipe lines, and building tanks, powers, stations and structures thereon to produce, save, and take care of said products, all that certain tract of land, situate in the County of Tulsa, State of Oklahoma, described as follows to-wit:
An undivided $1/2$ interest in the North Half (N_0^1) of the Northwest Quarter (NW_2^1) of the Southeast Quarter (SE_2^1) and the Southwest Quarter (SW_2^1) of the Northwest Quarter (NW_2^1) of the Southeast Quarter (SE_2^1)
of section 7 Township 20N Range 13 E. and containing Thirty (30) acres, more or less. It is agreed that this lease shall remain in force for a term of Five (5) years from this date, and as long thereafter as oil or gas, or either of them is produced from said land by the lessee. In consideration of the premises the said lessee covenants and agrees: 1st. To deliver to the credit of lessor, free of cest, in the pipe line to which he may connect his wells, the equal one-eighth part of all oil produced and saved from the leased premises.
2nd. To pay lessor one-eighth royalty, prevailing market rate Dollars each year, in advance, for the gas from each well where gas only is found, while the same is being used off the premises and if used in the manufacture of gasoline or any other product, a royalty of one-eighth (1/8), payable monthly at the prevailing market rate; and lessor to have gas free of cost from any such well for all stoves and all inside lights in the principal dwelling house on said land during the same time by making their own connection with the well at their own risk and expense.
3rd. To pay lessor for gas produced from any oil well and used off the premises or in the manufacture of gasoline or any other product at the rate of one-eighth royalty Dollars per year for the time during which such gas shall be used, payable one-eighth royalty or a royalty of one-eighth (1/8) payable monthly at the prevailing market rate.
