Lessee shall have the right at any time to renove all machinery and fixtures placed on said premises, including the right to draw and remove casing. If the estate of either party hereto is assigned, and the privilege of assigning in whole or in part is expressly allowed—the covenants hereof shall extend to their heirs, exceutors, administrators, successors or assigns, but no change in the ownership of the land or assignment of rentals or royalties shall be binding on the lessee until after the lessee has been furnished with a written transfer or assignment or a true copy thereof; and it is hereofy agreed in the event this lesses shall be assigned ta to a part or parts of the above described lands and the assignee or nasignees of such part or parts shall fail or make default in the payment of the proportionate part of the rents due from him or them, such default shall not operate to defeat or affect this lesse in so far as it covers a part or parts of said lands which the said lessee or any assignee thereof shall make due payment of said rental.
