In consideration of the premises the said lesses covenants and agrees; 1st. To deliver to the credit of lessor, free of cost, in the pipe line to which they may connect their wells, the equal one-eighth part of all oil ced and saved from the lessed premises.

2nd. To pay lessor the equal one-eight (1/8) part of all the gas from each well where gas only is found, while the same is being used off the premises, and if used in the manufacture of gasoline or any other product, a royalty of one-eighth (1/8), payable monthly at the prevailing market rate; and lessor to have gas free of costfrom any such well for all stoves and all inside lights in the principal dwelling house on said land during the same time by making his own connections with the well at his own risk and such expense.

Srd. To pay lessor for gas produced from any oil well and used off the premises or in the manufacture of gasoline or any other product at the rate of - - a royalty of one-eighth (1/8) payable monthly at the prevailing market rate.
