In consideration of the premises the said lessee covenants and agrees: Ist. To deliver to the credit of lessor, free of cost, in the pipe line to which <u>he</u> may connect<u>his</u> wells, the equal one-eighth part of all oil produced and saved from the leased premises.

2nd. Wo pay the lessor one-eighth of the proceeds by lesse from the sale of gas from each well where gas only is found, while the same is being used off the premises, and lessor to have gas free of cost from any such well for all stoves and all inside lights in the principal dwelling house on said land during the same time by making his own connections with the wells as his own risk and expense, except when used by lassee to extract gasoline therefrom.

3rd. To pay lessor for gas produced from any oil well and used off the premises for any purpose other than to extract gasoline therefrom one-eighth of the proceeds received by lessee from the sale of such gas for the time during which such gas shall be used, said payments to be made quarterly or if sold by lessee to extract gasoline therefrom, lessor shall receive one-eighth of the amount received therefor by the lessee.
