It is agreed that this lease shall remain in force for a term of ______5___years from this date, and as long thereafter as oil or gas, or either of them is produced from said land by the lessee. In consideration of the premises the said lessee covenants and agrees: 1st. To deliver to the credit of lessor, free of cost, in the pipe line to which <u>he</u>____may connect <u>his</u>____wells, the equal one-eighth part of all oil produced and saved from the leased premises.

2nd. To pay lessor Royalty of one eight (1/8) Market Rate Dollars each year, in advance, for the gas from each well where gas only is found, while the same is being used off the premises, and if used in the manufacture of gasoline or any other product, a royalty of one-eighth (1/8) payable monthly at the prevailing market rate; and lessor to have gas free of cost from anysuchwell for all stoves and all inside lights in the principal dwelling house on said land during the same time by making his own connections with the well at his own risk and expense.

To pay lessor for gas produced from any oil well and used off the premises or in the manufacture of gasoline or any other product at the rate of Royalty One Eight Dollars per year for the time during whichsuch gas shall be used, payable - or a royalty of one-eighth (1/8) payable monthly at the provailing market rate.
