DOLLARS. cash in hand paid, receipt of which is hereby acknowledged and of the covenants and agreements hereinafter contained on the part of lessee to be paid, kept and performed, had\_\_granted, demised, leased and by these presents do82.\_grant, demise, lease and let unto the said lessee, for the sole and only purpose of mining and operating for oil and gas, and of laying of pipe lines, and building tanks, powers, stations and structures thereon to produce, save, and take care of said products, all that certain tract of land, situate in the County of Tulsa, State of Oklahoma, described as follows to-wit: East one-half (E2) of the SouthEast one-quarter (SE2) of section 36 Township 21 N. Range 13 F. and containing Eighty (80) acres, more or less. It is agreed that this lease shall remain in force for a term of 0ne (1) years from this date, and as long thereafter as oil or gas, or either of them is produced from suid land by the lessee. In consideration of the premises the said lessee covenants and agrees: Ist. To deliver to the credit of lessor, free of cost, in the pipe line to which it may connect its wells, the equal one-eighth part of all oil produced from the lessed. 2nd. To paylessor one-eighth(1/8) of gross proceeds for the gas from each.well where gas onlyis found, while the same is being used off the premises, and if used in the manufacture of gasoline or any other product, a royalty of one-eighth(1/8) payable monthly at the prevailing market rate; and lessor to have gas free of cost from anysuch well for all stoves and all inside lights in the principal dwelling house on said land during the same time by making his own connections with the well at his own risk and expense. 3rd. To paylessor for gas produced from anyoil well and used off the premises or in the manufacture of gasoline or anyother product at the rate of one-eighth (1/8) for the time during which such gas shall be used, payable monthly or a royalty of one-eighth (1/8) payable monthly at the prevailing market rate.
