To deliver to the credit of lessor, free of cost, in the pipe line to which_____may connect_____wells, the equal one-eighth part of all oil and saved from the leased premises. 1st.

2nd. To pay lessor for gas from each well where gas only is found, the equal one-eighth (1/8) of the gross proceeds at the prevailing market rate, for all gas used off the premises, said payments to be made monthly and lessor to have gas free of cost from any such well for all stoves and all inside lights in the principal dwelling house on said land during the same time by making his own connections with the well at his own risk and expense. risk and expense.

3rd. To pay lessor for gas produced from any oil well and used off the premises, or for the manufacture of casing-head gas, one-eighth (1/8) of the gross proceeds at the prevailing market rate for the gas so used, for the time during which such gas shall be used, said payments to be made Monthly.

If no well be commenced on said land on or before the 13th ______ day of ______ No vember _______ 19_24___, the lease shall terminate as to both parties, unless the lesses on or before that date shall pay or tender to the lessor, or the lessor's credit in the------___or its successors, which shall continue as the depository regardless of changes in the ownership Bank at__

Lessee shall have the right to use free of cost, gas, oil and water produced on said land for <u>119</u>...operations thereon, except water from well of lessor. When requested by lessor, lessee shall bury <u>h19</u> pipe lines below plow depth. No well shall be drilled nearer than 200 feet to the house or barn now on said premises, without the written consent of the lessor. Lessee shall pay for damages caused by <u>119</u> operations to growing crops on said land. Lessee shall have the right at any time to remove all machinery and fixtures placed on said premises, including the right to draw and remove casing. If the estate of either party hereto is assigned, and the privilege of assigning in whole or in part is expressly allowed—the covenants hereof shall extend to their heirs, executors, administrators, successors or assigns, but no change in the ownership of the land or assignment of rentals or royalties shall be binding on the lessee intil after the lessee has been furnished with a written transfer or assignment or a true copy thereof; and it is hereby agreed in the event this lease shall be assigned as to a part or parts of the above described lands and the assigneer or assignment or affect this lease in so far as it covers a part or parts of said lands which the said lessee or any assignee thereof shall make due payment of said rental. Lessor hereby warrants and agrees to defend the tile to the lands herein described, and agrees that the lessee shall have the right at any time to redeem for lessor, hy payment, any mortgages, taxes or other liens on the above described lands, in the event of default of payment by lessor, and be subrogated to the rights of the holder thereof.
