To pay the lessor one-eighth value of gas from each well where gas only is found, while the same is being used off the premises, and lessor to have gas free of cost from any such well for all stoves and all inside light in the principal dwelling house on said land during the same time by making his own connections with the wells at his own risk and expense. 3d. To pay lessor for gas produced from any oil well and used off the premises or for the manufacture of casing-head gas one sighth per year, for the time during which such gas shall be used, said payments to be made monthly as sold. as to both parties, unless the lessee on or before that date shall pay or tender to the lessor, or the lessor's credit in the Bank at\_\_\_\_\_\_or its successors, which shall continue as the depository regardless of changes in the ownership Lessee shall have the right to use free of cost, gas, oil and water produced on said land for \_\_\_\_\_\_\_. operations thereon, except water from well of lessor. When requested by lessor, lessee shall bury \_\_\_\_\_\_\_ pipe lines below plow depth. No well shall be drilled nearer than 200 feet to the house or barn now on said premises, without the written consent of the lessor. Lessee shall have the right at any time to remove all machinery and fatures placed on said premises, including the right to draw and remove casing.
