Bank at <u>National</u> or its successors, which shall continue as the depository regardless of changes in the ownership

Lesser shall have the right to use tree of cost, gas, oil and water produced on said land for <u>1.5.5</u> operations thereon, except water from well of lessor.
When requested by lessor, lessee shall bury <u>his</u> pipe lines below plow depth.
No well shall be drilled nearer than 200 feet to the house or barn now on said premises, without the written consent of the lessor.
Lessee shall have the right at any time to remove all machinery and fixtures placed on said premises, including the right to draw and remove casing.
