If the estate of either party hereto is assigned, and the privilege of assigning in whole or in part is expressly allowed—the covenants hereof shall extend to their heirs, executors, administrators, successors or assigns, but no change in the ownership of the land or assignment of rentals or royalties shall be binding on the lessee until alter the lesse thas been furnished with a written transfer or assignment or a true copy thereoi, and it is hereby agreed in the event this lesse shall be assigned as to a part or parts of the above described lands and the assignee of assigning to a fare still less or a low there or a part or parts of the brow default in the payment of said rental. Lessor hereby warrants and agrees to defend the title to the lands herein described, and agrees that the lessee shall have the right at any time to redeem for lessor, by payment, any mortgages, taxes or other liens on the above described lands, in the event of default of payment by lessor, and be subrogated to the rights of the holder thereot. Lessee agrees to commence the drilling of a well. for the production of oil and gaß on the W2 of NW4 of Sec. 27-T21N-R13E within 60 days from this date and to drill said well with reasonable diligence and dispatch to the depth of the Wilcox sand and if oill or gas is discovered in paying quantities in said well, the lessee agrees to commence drilling a well on the land covered by this lease within 30 days after such discovery and complete such wellwith reasonable diligence.
