In consideration of the premises the said lessee covenants and agrees: Ist. To deliver to the credit of lessor, free of cost, in the pipe line to which he _____ may connect his _____ wells, the equal one-eighth part of all oil produced and saved from the leased premises.

2nd. To pay lessor for gas from each well where gas only is found, the equal one-eighth (1/8) of the gross proceeds at the prevailing market rate, for all gas used off the premises, said payments to be made quarterly and lessor to have gas free of cost from any such well for all stoves and all inside hights in the principal dwelling house on said land during the same time by making his own connections with the well at his own risk and expense.

3rd. To pay lessor for gas produced from any oil well and used off the premises, or for the manufacture of casing-head gas, one-eighth (1/8) of the gross proceeds at the pre-vailing market rate for the gas so used, for the time during which such gas shall be used, said payments to be made quarterly. or for

If no well be commenced on said land on or before the <u>31st</u> day of <u>January</u> <u>19 25</u>, the lease shall terminate as to both parties, unless the lessee on or before that date shall pay or tender to the lessor, or the lessor's credit in the <u>La Grange State</u> Bank at La Grange, Indiana or its successors, which shall continue as the depository regardless of changes in the ownership of said land, the sum of <u>Porty and No/100</u> DOLLARS, which shall operate as a rental and cover the privileges of deferring nding that

Lessor hereby warrants and agrees to defend the title to the lands herein described, and agrees that the lessee shall have the right at any time to redeem for lessor, by payment, any mortgages, taxes or other liens on the above described lands, in the event of default of payment by lessor, and be subrogated to the rights of the holder thereof.

Lessor shall have the right to use said land subject to rights of Lessee to mine and operate for oil and gas and other rights herein granted.
