To deliver to the credit of lessor, free of cost, in the pipe line to which <u>he</u> may connect <u>his</u> wells, the equal one-eighth part of all oil ced and saved from the leased premises. 2nd. To pay lessor for gas from each well where gas only is found, the equal one-eighth (1;6) of the gross proceeds at the prevailing market rate, for all gas used off the premises, said payments to be made Monthly. and lessor to have gas free of cost from any such well for all stoves and all inside lights in the principal dwelling house on said land during the same time by making his own connections with the well at his own risk and energy. risk and expense. 3rd.
