WITNESSETH, That the said lessor, for and in consideration of <u>One</u> DOLLARS. cash in hand paid, receipt of which is hereby acknowledged and of the covenants and agreements hereinafter contained on the part of lessee to be paid, kept and performed, ha. 9. granted, demised, leased and let and by these presents do. 9.8. grant, demise, lease and let unto the said lessee, for the sole and only purpose of mining and operating for oil and gas, and of laying of pipe lines, and building tanks, powers, stations and structures thereon to produce, save, and take care of said products, all that certain tract of land, situate in the County of Tulsa, State of Oklahoma, described as follows to-wit:

The South Half (S2) of the Southeast Quarter (SE2)

Township 21 Range 13 E. and containing 80 acres, more or less. this lease shall remain in force for a term of 5, or 10 acres, more or less. of section____12

2nd. To pay lessor One Eighth each year, for the gas from each well where gas only is found, while the same is being used off the premises, and if used in the manufacture of gasoline or any other product, a royalty of one-eighth (1/8), payable monthly at the prevailing market rate; and lessor to have gas free of cost from any such well for all stoves and all inside lights in the principal dwelling house on said land during the same time by making her own connections with the well at her own risk and expense.

3rd. To pay lessor for gas produced from any oil well and used off the premises or in the manufacture of gasoline or any other product at the rate of One Eighth per year for the time during which such gas shall be used, payable - - or a royalty of one-eighth (1/8) payable monthly at the prevailing market rate.

If no well be commenced on said land on or before the _____ 29th _____ day of ____ August 19 25 ., the lease shall terminate as to both parties, unless the lessee on or before that date shall pay or tender to the lessor, or the lessor's credit in the VeraiState Bank at <u>Vera</u>, Okla. Or its successors, which shall continue as the depository regardless of changes in the ownership of said land, the sum of <u>Eighty</u> and No/100 ______DOLLARS, which shall operate as a rental and cover the privileges of deferring
