either of them is produced from said land by the lessee.
1st. To deliver to the credit of lessor, free of cost, in the pipe line to which. he may connect. his wells, the equal one-eighth part of all oil produced and saved from the leased premises.
2nd. To pay lessor for gas from each gas well where gas only is found, the equal one-eighth $(1/8)$ of the gross proceeds at the prevailing market rate, for all gas used
off the premises, said payment to be made and lessor to have gas free of cost from
any such well for all stoves and all inside lights in the principal dwelling house on said land during the same time by making his own connections with the wells at his own
risk and expense.
3rd. To pay lessor for gas produced from any oil well and used off the premises or for the manufacture of casing-head gas, one eighth (1/8) of the gross proceeds at the
