In consideration of the premises the said lessee covenants and agrees: Ist. To deliver to the credit of lesser, free of cost, in the pipe line to which they may connect their wells, the equal one-eighth part of all oil produced and saved from the leased premises.

2nd. To pay lessor a royalty of one-eighth (1/8) payable monthly at prevailing market rate, for the gas from each well where gas only is found, while the same is being used off the premises, and if used in the manufacture of gasoline or any other product, a royalty of one-eighth (1/8), payable monthly at the prevailing market rate; and lessor to have gas free of cost from any such well for all stoves and all inside lights in the principal dwelling house on said land during the same time by making his own connections with the well at his own risk and expense.

3rd. To pay lessor for gas produced from any oil well and used off the premises or in the manufacture of gasoline or any other product a royalty of one-eighth (1/6) payable monthly at the prevailing market rate.

No well shall be drilled nearer than 200 feet to the house or barn now on said premises, without the written consent of the lessor. Lessee shall have the right at any time to remove all machinery and fastures placed on said premises, including the right to draw and remove casing. If the estate of either party hereto is assigned, and the privilege of assigning in whole or in part is expressly allowed—the covenants hereof shall extend to their hoirs, exceetors, administrators, successors or assignes, but no change in the ownership of the land or assignment of rentals or royalties shall be binding on the lessee until after the lessee has been furnished with a written transfer or assignment of a true copy thereof; and it is hereby agreed in the event this lease shall be assigned as to a part or parts of the above described lands and the assignee of such part or parts shall fail or marke default in the payment of the propritionate part of the rents due from him or them, such default shall not operate to defeat to alfase this lease in so far as it covers a part or parts at lands which the said lessee or any assignee thereof shall make due payment of said rental.
