In consideration of the premises the said lessee covenants and agrees: 1st. 2d. To pay the lessor - - - - Dollars, each year in advance, for the gas from each well where gas only is found, while the same is being used off the premises, and lessor to have gas free of cost from any such well for all stoves and all inside lights in the principal dwelling house on said land and during the same time by making his own connect-ions with the wells at his own risk and expense.

3d. To pay lessor for gas produced from any oil well and used off the premises at the rate of - - Dollars per year, for the time during which gas shall be used, said payments to be made each three months in advance.
