It is agreed that this lease shall remain in force for a term of <u>5</u>. either of them is produced from said land by the lessee. In consideration of the premises the said lessee covenants and agrees: Ist. To deliver to the credit of lesser, free of cost, in the pipe line to which <u>he</u> may connect <u>his</u> wells, the equal one-eighth part of all oil produced and saved from the lessed premises. 2d. To pay the lessor one-eighth value of gas from each well where gas only is found, while the same is being used off the premises, and lessor to have gas free of cost from any such well for all stoves and all inside light in the principal dwelling house on said land during the same time by making his own connections with the wells at his own risk and expense. 3d. To pay lessor for gas produced from any oil well and used off the premises or for the manufacture of casing-head gas the equal one eighth part for the time during which such gas shall be used, said payments to be made monthly.
