hearing, it being one of the regular days of the July term of the County Court of Tulsa County, Oklahoma, with the petitioners Cornelia Brock, John Brock and Homer Brock in court in person and represented by their attorney Frank E. Duncan and the matters before the court being the determination of the heirship of John Brock, deceased, and the petition for such determination of heirship having been filed by the said petitioners Cornelia Brock, John Brock and H_omer Brock, the said Cornelia Brock being the wife of John Brock and Cornelia Brock, and the said Cornelia Brock being the children of John Brock and Cornelia Brock, and the said Cornelia Brock, John Brock and Homer Brock being the only heirs of John Brock, deceased and all of said parties being now and for more than five years last past residents of Tulsa County, Oklahoma, and there being no appearance of any other heirs, executors, administrators, devisees, trustees and assigns immediate or remote of the said John Brock, deceased, and there being no objections filed or öffered herein and the court having taken the evidence in said cause and being fully advised in the premises, FINDS:

That John Brock, deceased was and had been for more than five years prior to his death, a resident of Tulsa County, Oklahoma.

That the said John Brock deceased died in the City of Tulsa, County of Tulsa, State of Oklahoma, on the 22nd day of October, 1917

That at the time of the death of the said John Brock deceased, he left surviving him, a wife Cornelia Brock and two sons, John Brock, and Homer Brock.

That at the time of the death of the said John Brock, deceased, he the said John Brock was the owner in fee of Lots one (1), two (2), and three (3) in Block Two (2) Overlook Park Addition to the City of Tulse, Oklahoma, as per the recorded amended plat thereof all being situate in the County of Tulsa, State of Oklahoma.

The court further finds that the said John Brock, deceased and the said Cornelia Brock petitioner herein were married in Red River County, State of Texas twenty six years ago and have lived together as man and wife from that date to the time of the death of the said John Brock, deceased as herein set out.

The Court further finds that the said John Brock, deceased was married to a woman by the name of Mattie Cox about thirty years ago this date and that the said Mattie Cox died about one year after the date of said marriage in giving birth to a child and that said child died about three months later and that there were no other children of the said mariage of the said John Brock, deceased and the said Mattie Cox,

That the said John Brock, deceased and the said Cornelia Brock have had two children,towit, the said John Brock and Homer Brock petitioners herein.

The court further finds that the said John Brock petitioner herein and son of the said John Brock, deceased, is now and for more than five years last past has been a resident of Tulsa County, Oklahoma; residing at the present time at No. 328 North Sante Fe Street, Tulsa, Oklahoma; that the said Homer Brock, petitioner herein and son of John Brock, deceased is now and for more than five years last past has been a resident of Tulsa County, Oklahoma, residing at No. 1401 West Archer Street in the City of Tulsa, Oklahoma, with his mother Cornelia Brock, petitioner herein.

The court further finds that there are no other heirs of the said John Brock, deceased, save and except Cornelia Brock, wife of the deceased John Brock, the said John Brock son of the deceased John Frock and the said Homer Brock son of the deceased John Brock and that the said heirs are the sole and only heirs of the said John Brock, deceased.
