The court further finds that the petition for determining heirship herein in said County Court of Tulsa County, Oklahoma, being probate No. 4574, was filed in the Probate Court of Tulsa County, Oklahoma, on the 11th day of May, 1923, and the hearing therein set forth July 9, 1923, at nine o'clock A. M. at which time the court being engaged in other business and there being no objections, said hearing was continued to July 14, 1923, at nine o'clock A. M. at which time said cause came on regular for hearing as herein provided.

The court further finds that a copy of said summons was personally delivered to Cornelia Brock, petitioner herein in Tulse, Tulsa County, Oklahoma, and the said Cornelia Brock did accept personal service of said summons on the 11th day of May, 1923.

The court further finds that the said Cornelia Brock petitioner herein was the legal and lawful wife of the said John Brock, deceased at the time of his death and is the legal and lawful heir of the said John Brock, deceased and entieled to an undivided onethird interest in and to the real estate herein described belonging to the said John Brock, deceased.

The court further finds that John Brock one of the petitioners herein is the son of John Brock, deceased and Cornelia Brock petitioner herein and is a legal and lawful heir of John Brock, deceased and entitled to an undivided one-third interest in and to the real estate herein described belonging to the said John Brock, deceased at the time of his death.

The court further finds that Homer Brock one of the petitioners herein is the son of John Brock, deceased and Cornelia Brock, petitioner herein and is a legal and lawful heir of John Brock, deceased and entitled to an undivided one-third interest in and to the real estate herein described belonging to the said John Brock, deceased at the time of his death.

The court further finds that service was had upon the heirs, executors, devisees administrators and assigns immediate and remote who were unknown to the petitioners herein by publication inmanner and form provided by law; that said publication notice was filed in this cause on the llth day of May, 1923, the date for hearing therein was set for July 9, 1923; that said notice was published in the Tulsa Daily Legal News for three webks and such publication was on Thursday May 17, 1923, Thursday May 24, 1923, Thursday May 31, 1923 and on Thursday June 7, 1923.

The court further finds that there has been no objections or any appearance filed herein or no person or persons or anyone representing same appearing herein save and except the said Cornelia Brock, John Brock and Homer Brock heirs of the said John Brock, deceased as herein set out.

The court further finds that the said John Brock deceased died intestate without any legal will or disposition of his property.
