ASSIGNMENT OF OIL AND GAS LEASE.

WHEREAS, on the 18th day of May, 1923, a certain cil and gas mining lease was entered into by and between Mrs. Cassie D. Henderson, nee Jenkins, Lessor, and L. S. Henderson, Lessee, covering the following described property inthe County of Tulsa, State of Oklahoma, to-wit:

The East Half of the Northeast quarter, and the Southwest Quarter of the Northeast Quarter, of Section 24, Township 18 North, Range 14 East,

containing 120 acres, more or less;

WHEREAS, said lease and all rights thereunder or incident thereto are now powned by L. S. Henderson of Tulsa, Oklahoma;

NOW,THEREFORE, for an inconsideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged, and the further payment of the sum of One Hundred and Fifty Dollars (\$150.00) out of the first oil run from said lease to the credit of the one-sixteenth interest hereinafter conveyed, the indersigned, the present owner of said lease and all rights thereunder or incident thereto, does hereby bargain, sell, transfer, assign and convey unto Joseph M. Wren, his heirs , successors and assigns, an undivided one-sixteenth interest of all the right, title and interest of the original lessee and present owner in and to said lease and all rights thereunder, insofar as it covers all of the above described property, together with all personal property used or obtained in connection therewith, to Joseph M. Wren, his heirs, successors and assigns, and also an undivided one-sixteenth interest in the first well drilled on said land after the date of this assignment, said well to be commenced on or before October 15th, 1923, and proceeded with to completion with due diligence and without unnecessary delay, said well to be drilled and completed into the tank without further cost to the assignee herein, his heirs, successors or assigns.

And for the same consideration, the undersigned for himself and his heirs, successors and representatives, does covenant with the said assignee, his heirs, successors or assigns, that he is the lawful owner of said lease and rights and interests thereunder, and of the personal property thereon or used in connection therewith; that the undersigned has good right and authority to sell and convey the same, and that said rights, interest and pro perty are free and clear from all liens and incumbrances, and that all rentals and roylties due and payable thereunder have been duly paid.
