THIS INDENTURE, Made this 7th day of July in the year  
of our Lord, One Thousand nine hundred and Twenty-  
three between B. F. Gray and Minnie E. Gray, husband  
and wife of Tulsa County, Oklahoma, of the first  
part and the OKLAHOMA FARM MORTGAGE COMPANY, a corporation of Oklahoma City, Oklahoma,  
of the second part.

WITNESSETH, That the said parties of the first part have mortgaged and do  
hereby mortgage to party of the second part, the following described real estate, situated  
in Tulsa County, Oklahoma, to-wit:

The North One-half of the Northeast quarter and the North One-half of  
the Southwest quarter of the Northeast quarter and the Northwest quarter  
of the Southeast quarter of the Northeast quarter of Section Twenty-one
