when due, or fail to perform all and singular the covenants and agreements herein contained the entire debt remaining secured by this mortgage shall at once become due and payable at the option of the holder, without notice, and this mortgage may therefore be foreclosed immediately for the whole of said debt, interests, costs, and other amounts payable hereunder. FOR NON-SECOND -- Should the said Mortgagors, their heirs, legal representatives or PAYMENT TAXES

assigns, fail to make payment of any taxes, assessments, fire insurance premiums and other charges payable by them, the said Mortgagee, may at its option make payment thereof, and the amounts so paid with interest thereon at ten per centum per annum shall be added to and become part of the debt secured by this mortgage without waiver of any rights arising from breach of any of the covenants, and for such payment with interest as aforesaid the premises hereinbefore described as well as the Mortgagors , their heirs, legal representatives and assigns, shall be bound to the same extent that they are bound for the payment of the notes herein described.

THIRD--In case any bill or petition is filed in an action brought to foreclose this mortgage, the Court may on motion of the Mortgagee, its successors or assigns, without respect to the condition or value of the property
